### **PRODUCT & INNOVATION THEATERS**

Product & Innovation Theaters provide an opportunity for commercial organizations (Sponsors) to present information about their product(s), service(s), or therapeutic area(s) and are not considered part of the 2026 Tandem Meetings | Transplantation & Cellular Therapy Meetings of ASTCT and CIBMTR (Tandem Meetings). The Sponsor or Sponsor's designated third-party meeting planning organization is responsible for all aspects of Sponsor's participation in the Product & Innovation Theaters, including planning, promotion, management, and payment of all associated costs. Associated costs can include but are not limited to catering, additional meeting room rental, additional audiovisual equipment, electrical services, and labor.

Product & Innovation Theaters must be conducted in accordance with all applicable federal, state, and local laws, including but not limited to FDA regulations. Providing gifts (items of value which are not approved as promotional materials, as described herein) to Product & Innovation Theater attendees is prohibited. The material presented in Product & Innovation Theaters is promotional and may concentrate on a specific product, service, or therapeutic area. **Therefore, these sessions may not offer continuing medical education credit.** 

### **APPLICATION PROCESS**

Product & Innovation Theaters may only be conducted upon approval by the Tandem Meetings staff. Potential Sponsors can reserve an opportunity by submitting your application through our floorplan management system by December 10, 2025 along with a non-refundable 25% deposit to The Medical College of Wisconsin/Tandem Meetings. Applications are processed on a first-come, firstserved basis. Space is limited for this activity; therefore, a slot cannot be held without a deposit.

Applications will be accepted from third party organizations on behalf of a potential Sponsor only if accompanied by a letter on the potential Sponsor's letterhead confirming its desire to participate in the Product & Innovation Theater and authorizing the third-party organization to act on its behalf regarding the Product & Innovation Theater. This letter should be sent to the Tandem Meetings Support Office via <u>email</u>.

Tandem Meetings staff will notify those Sponsors approved to participate and will provide the assigned date, time, and room for the Product & Innovation Theater. Full participation fee is due within 30 days of Sponsor's receipt of application approval notification, or the Product & Innovation Theater space will be released to another Sponsor.

### SCHEDULE AND LOCATION

Product & Innovation Theaters are available for either 30- or 60-minute timeslots. Permissible timeslots are outlined below; these timeslots were selected during times that will not conflict with Tandem Meetings programming. All Product & Innovation Theaters will be held in the Exhibit Hall of the Salt Palace Convention Center. All time slots will be scheduled by the Tandem Meetings staff.

## **PARTICIPATION FEES**

The Product & Innovation Theater participation fees are as follows:

- 30-minutes: \$32,000
- 60-minutes: \$52,000

### REGISTRATION

#### Speakers:

Speakers of Product & Innovation Theaters must be registered attendees of the 2026 Tandem Meetings. The Sponsor or Sponsor's designated third-party meeting planning organization are responsible for ensuring speaker registration. Tandem Support **will not** provide a complimentary registration code for speakers of Product & Innovation Theaters.

### Attendees:

Product & Innovation Theater attendee registration is required and will be handled by the Sponsor or the Sponsor's designated third-party meeting planning organization. Because Product & Innovation Theaters are not associated with the Tandem Meetings, Sponsors are advised to provide specific details and contact information on how attendees should register for this activity.

### Staff:

Staff who attend the Tandem Meetings for the purpose of staffing sponsored Product & Innovation Theaters may contact Tandem Support staff via <u>email</u> to discuss registration options. Please limit one contact per Product & Innovation Theater.

### **PROMOTIONAL MATERIALS**

All materials intended to promote Product & Innovation Theaters must be approved by the Tandem Meetings staff prior to release and distribution, including advertisements, announcements, broadcast e-mail messages, brochures, envelopes, flyers, invitations, press releases/media communications, signage, solicitations, websites, and other materials (Promotional Materials) by Monday, January 12, 2026.

As changes to promotional materials may be required, it is strongly recommended that review and approval by Tandem Meetings staff occur before printing or production of the same.

## All approved promotional materials must contain the following statement in a prominent type size and location:

"This promotional activity is provided by [INSERT SPONSOR NAME] and is not certified for continuing education credit. The content of this Product & Innovation Theater and opinions expressed by presenters are those of the sponsor or presenters and not of the Tandem Meetings, ASTCT or CIBMTR."

No other phrase or reference to ASTCT, CIBMTR, or the Tandem Meetings is permitted on promotional materials. Neither the Tandem Meetings name nor Tandem Meetings graphics may be used on promotional materials. The words "education," "educational," or "symposium" and phrases such as "presented during" or "presented in conjunction with" are also prohibited on promotional materials. This rule applies to materials developed for use before, during and after the event.

### **ONLINE AGENDA**

The Tandem Meetings will post the title and agenda of Product & Innovation Theaters in the online agenda. Both the title and agenda must be <u>emailed</u> to Tandem Support by Monday, December 1, 2025. The names of speakers and chairs will <u>not</u> be posted in the online agenda.

## SIGNS

A total of two signs, professionally produced and at Sponsor's cost, may be displayed either outside the assigned meeting room and/or in the convention center pre-function area, at the discretion of the Tandem Meetings. Signs are not to exceed 26"x63" pop up banner or 24"x36" mounted poster. Permission must be given by Tandem Meetings staff for placement of presentation flyers or signs in any other area of the meeting hotels or the convention center, except for the Sponsor's Tandem Meetings exhibit booth. The Tandem Meetings reserves the right to remove and discard signs and flyers of any Sponsor or organization violating this policy.

## CATERING AND CONVENTION CENTER

Sponsors are responsible for making all catering arrangements associated with their Product & Innovation Theater directly with Sodexo Live! the catering company for the Salt Palace Convention Center. Additionally, all audio-visual arrangements should be made with FMP Media Solutions. The Tandem Meetings staff will provide the contact information to Sponsor's primary contact for both catering and audio visual. After Product & Innovation Theater assignments have been provided to Sponsors, the Tandem Meetings of ASTCT and CIBMTR assumes no responsibility for the loss or reduction of meeting space, nor convention center or other costs associated with the Product & Innovation Theater, including but not limited to set-up charges, additional room rental, audio visual, food and beverage, hotel reservations, speaker arrangements, electric, etc.

The Tandem Meetings of ASTCT and CIBMTR reserves the right to ask Sponsors to switch their assigned space due to lower than expected attendance figures. If this occurs, the Tandem Meetings of ASTCT and CIBMTR will not provide associated compensation.

Arrangements for food and beverage selections (if applicable), and billing must be made directly with representatives of Sodexo Live!, the catering company the Salt Palace Convention Center. They can provide menus upon request. Sponsor or Sponsor's designated third-party meeting planning organization are responsible for all expenses incurred related to their Product & Innovation Theater participation. The Tandem Meetings of ASTCT and CIBMTR, ASTCT and CIBMTR bear no financial obligation for expenses incurred by Sponsors for Product & Innovation Theaters.

When designing staging and production for the Product & Innovation Theater, please keep in mind that in most cases set up time will be limited to 30-60 minutes. All additional AV equipment and requests must be included and paid for in the Product & Innovation Theater application. The application may be edited to add additional requests.

The Tandem Meetings of ASTCT and CIBMTR reserves the right to restrict and/or dismiss at any time and in its sole discretion any Product & Innovation Theater exhibit or portion thereof, including Sponsor representative(s), it deems undesirable, in poor taste, or offensive to attendees.

### **CHANGES/WITHDRAWALS**

Changes to assigned time slots must be requested in writing to the Tandem Meetings of ASTCT and CIBMTR Conference Office via email and will be accommodated only if the requested time slot is available. The timeslots noted above have been approved by the Tandem Meetings of ASTCT and CIBMTR and may not be modified.

There will be no refunds for Product & Innovation Theater cancellations after **November 24, 2025**. For Sponsors who withdraw from participation before **November 24, 2025**, 50% of the fee will be nonrefundable and will be retained by the Tandem Meetings of ASTCT and CIBMTR, and the balance returned to the Sponsor.

Please note, the Tandem Meetings of ASTCT and CIBMTR do not guarantee attendance for Product & Innovation Theaters and will not refund fees based on attendance or lack thereof.

### LIMITATION OF LIABILITY

Mailing lists are only pulled one time before the start of the Tandem Meetings; additional versions will not be provided unless purchased.

**Registration Bag Insert:** The Tandem Meetings Registration Bag Insert may be used to promote Product & Innovation Theaters. See the <u>rate card</u> for more information (available in fall 2025).

**Exhibits:** Sponsor representatives may distribute invitations, flyers, etc. from within the Sponsor's assigned exhibit space during the Tandem Meetings of ASTCT and CIBMTR. The distribution of invitations, flyers, etc. is **strictly prohibited** in all public spaces of the convention center or other hotels.

*Signage:* Promotional signs are permitted within the size specifications listed on page 2 under signs, in the convention center pre-function area. Signs may not be posted until the preceding Product & Innovation Theater has ended and signs must be removed no later than two hours after conclusion of the Product & Innovation Theater.

### SECURITY AND INSURANCE

Sponsor agrees to abide by any amendments that may hereafter be adopted. Sponsor waives any rights or claims of damages arising out of enforcement of any terms or conditions contained herein.
