CIBMTR is a voluntary research organization of basic and clinical scientists collaborating to address important issues in blood and marrow transplantation and cellular therapy. - 3. **Approval** will be sent by Tandem Support once files have been reviewed. If changes are necessary, a copy of the revised insert must be re-submitted for final approval.
- 4. **Ship** Registration Bag Inserts to the Freeman Advance Warehouse by <u>January 23, 2026</u>. -or- **Email** Digital Meeting Bag files to Tandem Support by <u>January 9, 2026</u>.

#### FILE SPECIFICATIONS

#### **Digital Meeting Bag Insert**

- Content page max: 4 pages
- Must be submitted to Tandem Support as .jpg, .png, or .pdf file
- Due Date: January 9, 2026

#### **Registration Bag Insert:**

- Quantity: 5,000
- Maximum Dimension: 8 <sup>1</sup>/<sub>2</sub>" x 11"
- Maximum Weight: 4 oz.
- Double sided printing allowed
- Printing costs are at your own expense.
- Please submit an additional 3% overage to allow for a potential increase in onsite attendance.

• Tandem Support will not be responsible for shortages due to an incorrect number of inserts received. SHIPPING SPECIFICATIONS

- Complete a shipping label provided by the Tandem Meetings office for <u>each box</u> that is shipped.
- Shipping costs are at your own expense.
- The Tandem Meetings will not be responsible for inserts shipped to the incorrect location or using the incorrect shipping label.
- Inserts not received by January 23, 2026, will not be included in the registration bags.

#### RULES

- 1. All advertising is subject to the approval of the Tandem Meetings.
- 2. A minimum \$500 late fee will be charged for materials received after the deadline. Inserts not received by **January 23, 2026**, will not be included in the registration bags.
- 3. Full payment is due upon receipt of Application and Contract. All prices are net.
- 4. All signed agreements are firm. Cancellations are non-refundable.
- 5. No agency commission or cash discounts accepted.
- 6. All quantities are based on projected attendance at the time the rate card is published.
- 7. Additional costs will be incurred if the advertiser fails to comply with shipping instructions or to fully complete the shipping label provided. An insert is considered one 8-1/2" x 11" or smaller printed piece, maximum weight of 4 oz. Insert should be flat with no protruding items attached. Any insert that does not fit these specifications will be considered a "bulk item" and is subject to an additional fee. A "bulk item" is defined at the discretion of the Tandem Meetings.
- 8. The Tandem Meetings is not held liable if an attendee does not receive the Registration Bag. No discounts or refunds will be given.
- 9. A request for tracking information for shipments will be sent in January 2026; compliance is required to ensure Registration Bag Inserts are included in the Registration Bag.
